The mercantile tax adopted by the Chartiers Valley School District is effective as of July 27, 1960, and Scott Township Municipal Ordinance No. 1030-78 effective July 1, 1978.

Persons Covered: All those who sell either by wholesale or retail, goods, wares and merchandise. Excepted are non-profit groups, individuals or firms disposing of articles of their own growth, production or manufacture, public utilities, and sales in interstate commerce.

Rate of Tax: Wholesale: 1 mill on each dollar of annual gross business.
Retail: 1 ½ mills of each dollar of annual gross business.

Interest and Penalties: For failure to pay: 1.5% a month or fraction thereof.
For each failure to file a return: Fine of not more than \$100.00

Returns & Payment: The returns should be filed and payment made quarterly before November 1st, February 1st, May 1st and August 1st. If temporary or seasonal business is completed before quarterly return is due then return and payment is to be made within 7 days from the date of completion of the business.
